#### Job summary

The Finance & Accounting Manager provides operational leadership and oversight of the accounting, financial reporting, and treasury functions, ensuring accuracy, transparency, and compliance with statutory and international standards (IFRS). The position is responsible for managing the end-to-end financial service delivery, including general ledger, accounts payable and receivable, payroll accounting, cash management, and financial controls, in alignment with corporate policies and business goals. The role supports the Head of Finance in translating strategic financial objectives into efficient operational practices that strengthen financial governance, performance monitoring, and decision support across the organisation.

- Monitor and control accounts receivable and payable cycles, ensuring timely collections and payments.
- Liaise with banks and financial institutions to manage payments, credit facilities, and short-term investments.
- Support implementation of cash management automation tools and internal control mechanisms.

- Coordinate with tax advisors and KRA on compliance and advisory matters.

- Streamline accounting workflows, enhance automation, and reduce manual processing.
- Support IT and Head of Finance in implementing digital transformation initiatives in financial management.
- Maintain a high standard of documentation, accuracy, and confidentiality in financial operations.

### • Leadership, Team Management & Capacity Building

- Supervise other finance staff to ensure quality and timeliness of outputs.
